This nomination of the "Croxley Green History Website Team" for the Hazel Seeley Award is to recognise its achievement in making a collated documentation of the culture and history of the community of Croxley Green that is easily accessible for public viewing.

Historical material on Croxley Green dating back over two centuries has been gathered and collated by local historian and resident Margaret Pomfret during the last 20 years. Margaret was invited to join the committee of the Croxley Green Residents' Association (CGRA) in 2012 as it was realised that facilities and funding was needed to enable her collection to be made accessible to the community and wider public. It was decided that a dedicated website would provide an accessible resource which could grow as further material was discovered and added.

A Croxley Green History Website (CGHW) Team was formed consisting of CGRA committee members and local residents namely Margaret Pomfret, Ross Humphries, Fabian Hiscock, Barry Grant and Tony Munroe. As the CGRA website had already been designed and developed by Ross Humphries, he volunteered his expertise and experience to construct the CGHW. The project started in Feb 2013 and grants from the CGPC and from HCC Councillor Steve Drury's community fund contributed to equipment and development costs. The CGHW consists of 26 main categories each divided into many sub-categories. Historical photographs were restored as necessary and captioned by Margaret; along with a vast amount of word content that needed to be collated for uploading to the website. Local residents Lynn Whitterton and Julia Mathewson volunteered many hours of their time for editing and proof-reading text.

Original hard copy material, often in a poor state of preservation, has now been converted to electronic format, archived and stored securely for access by future generations.

The website was launched at a special community event in December 2015 in front of local council representatives, local organisations and groups along with a selection of Croxley residents. After the presentation the CGHW went live to the public.

The success of this resource to the community and to the wider public is evidenced by over 500visits each week and frequent enquiries from local, national and overseas interested parties.

In summary, the CGHW has been set up by a team of residents of the CG community, who volunteer their time for the benefit of the community and thus is an exemplary community project here nominated for the Hazel Seeley Award. If nomination of the Croxley Green History Website Team for the HSA is accepted, then Margaret Pomfret has agreed to be the nominated representative of the CGHW Team.
