LEE1541/20 Matters Arising

The Clerk advised Members that Fantastic Fireworks have been confirmed for NYE Fireworks 2020. The Clerk advised Members of the progress made in planning the VE Day 75th Anniversary event – an exhibition and dance performance will be held in the Community Centre in the afternoon and a guiz night in the evening.

LEE1542/20 Rangers Update

The Senior Ranger gave an update on the activities completed by the Rangers. In addition to their regular activities, they had updates on:

- A new raised bed has been built on the pre-school allotment; this increases the growing space to 6 raised beds.
- Weston Wood
 - Volunteer Litter Pick Sunday 26th January Cllr Hughes, 7 volunteers and 4 children removed 200kg of rubbish, which has made a dramatic difference to the appearance of the woodland.
 - Trees blown down during recent storms have been cleared.

The Green

- Damage by vehicle joyriding was notified to the PCSOs.
- Delivery lorries are damaging the verges of The Green by The Coach & Horses and Croxley House.
- Reinstating the width of the footpath by removing encroaching mud and grass.
- Fly tipping on Little Green Lane has been cleared away by TRDC.
- Stone's Orchard coppiced the hazel at the Guild entrance and removed overgrowth around Owens Way footpath to enable walkers to avoid walking too close to the badger set.
- Machine Maintenance annual service for hedge cutters and strimmers.
 Tractor grass cutting deck sharpened ready for cutting in Spring.

LEE1543/20 Mill Lane Petition

[Under Standing Order 13.1.10 it was agreed by Members to add this item to the Agenda]

A representative of Friends of Croxley Common Moor presented a petition at the office relating to Mill Lane. 160 signatories request that Mill Lane drainage and gullies are cleaned by HCC; Croxley Green Parish Council to clear the mud from Mill Lane once every winter; Croxley Green Parish Council to install physical obstacles to prevent unauthorised parking.

LEE1544/20 Mill Lane

The Clerk gave a verbal update to Members on the activities on Mill Lane.

- Croxley Green Parish Council has assumed day to day responsibility for Mill Lane.
- New public bridleway footpath sign installed at the top of Mill Lane by Hertfordshire Rights of Way to discourage car use.
- Dead trees and ivy on the edge of the woodland, adjacent to the tow path, have been removed.
- Ivy has been removed from Nuttfield House wall and the bank. Information board shows history of the wall. Wall to be assessed for integrity.
- Contractors will be installing a wooden knee rail from the end of the existing knee rail round the corner to the bollards.
- Reduced the height of the hedge between Mill Lane and the towpath.
