# CC2216/21 Grant Application from Croxley Green Residents Association

The Clerk introduced the grant application from Croxley Green Residents' Association who are seeking funding to pay for the services of an environmental planner to review and assist in responding to Part 1 Policies of the TRDC draft Local Plan consultation. This is in conjunction with the Joint Three Rivers Residents' Association (JTTRA). The green belt within Three Rivers will be under significant threat to meet the governments housebuilding targets. A councillor confirmed that the information gained from the environmental planner would be shared with the Parish Council to inform the Parish Council's response to the TRDC draft Local Plan.

The Vice-Chairman advised that a grant application would normally only be accepted once per financial year, but if required CGRA would be able to submit a further grant application in the current financial year.
